1. TENANT FIND ONLY (Let-Only Service)

For landlords who wish to manage the tenancy themselves.

1.1 Tenant Find Fee

Marketing, viewings, referencing, Right to Rent checks, drafting tenancy, move-in admin:

• 60% of the first month's rent (Minimum £350)

Example: If rent is $£2,000 \rightarrow Fee = £1,200$

1.2 What's Included

- Professional marketing & advertising across major portals
- Conducting all viewings
- Full referencing (credit, employment, landlord checks)
- Right to Rent checks
- Tenancy Agreement drafting
- Move-in documentation

1.3 Not Included

(Landlord responsibility)

2. RENT COLLECTION SERVICE

For landlords who want us to manage rent, compliance, and legal documents while they handle repairs.

2.1 Initial Setup Fee

• 60% of the first month's rent (Minimum £350)

Example: If rent is $£2,000 \rightarrow \text{Fee} = £1,200$

3. FULL MANAGEMENT SERVICE

3.1 Setup Fee

4. SHORT-LET / HOLIDAY LET SERVICE (<6 months)

Short-Let Letting & Management Fee

20% of total rent received

Short lets include extra admin, higher turnover, and increased management time.



5. MULTI-PROPERTY DISCOUNTS

For portfolio landlords:

Number of Properties	Management Fee	Notes
1-2	Standard 8%	
3-4	**7%**	Applied to all properties
5+	**6%**	Portfolio rate

Setup fees remain unchanged.

6. RENEWALS & CHECK-OUT FEES

- Tenancy renewal: £350 (Let-Only or Rent Collection services)
- Check-in (optional): £95
- Check-out (if not managed): £45

Full Management includes check-out for free.

MAINTENANCE & REPAIRS

6.1 Maintenance Coordination

No charge for arranging routine repairs under £100(apply to full management).

6.2 Landlord Authorisation Threshold

- Repairs up to £100.00 may be instructed without prior landlord approval.
- Repairs above £100.00 require landlord consent unless in an emergency.

6.3 Contractor Invoices

To management company or Landlord (on request)

7. SAFETY CERTIFICATES (Landlord Pays)

Gas Safety (CP12): £60



• EICR (Electrical): £80

• PAT testing: £40

EPC: £100

• Legionella inspection: £60

8. OTHER LANDLORD FEES (Optional)

• Deposit dispute handling: £45

• Licensing application (HMO/selective): £95

• Court attendance: £50/hour

• Rent review negotiation: £35

• Additional property inspection: £30

9. PROHIBITED FEES (FOR CLARITY)

We never charge tenants (in compliance with Tenant Fees Act 2019):

- Admin fees
- Inventory fees
- · Check-in/out fees
- Cleaning fees
- · Tenancy agreement fees
- Renewal fees
- Key cutting charges

All fees are landlord-only.
